1. David Davis, page 6-7 Question Asked:

...Who in the department, DJPR, briefed you on the Commonwealth Games?

... Can you provide those dates on notice?

Shaun Leane Response:

As per my answer to Mr Davis's question (on page 6), I was briefed by Simon Phemister (former Secretary of DJPR).

I don't have access to the diary I used as a Minister, therefore I cannot provide specific dates of when those briefings occurred. The Committee may wish to redirect the question to the Department of Jobs Skills Industry and Regions (DJSIR) or Department of Premier and Cabinet (DPC).

DJSIR Response:

The department's records indicate that the former Minister for Commonwealth Games Legacy was verbally briefed at ministers' meetings on the following dates:

- 12, 14, and 25 July 2022
- 1, 8, 15, 22, 23 and 29 August 2022.

The department's records indicate meetings were scheduled throughout September and October 2022 however these meetings did not proceed.

Further to regular scheduled meetings, from time-to-time senior departmental officials also engage with Ministers on matters relevant to their portfolios.
