'That this House notes the linkages between gambling harm and poor mental health and the subsequent devastating impacts upon many Victorian individuals and families, and calls upon the State Government to consider the following initiatives to help prevent and better support those experiencing gambling harm:

- (1) appropriate data collection by the Coroners Court of Victoria to understand the number of suicides occurring as a result of gambling related issues;

- (2) advocacy to the Federal Government to provide for better regulation and oversight of online gambling companies, given there are few checks and balances with respect to a person having experienced gambling harm being able to open new online betting accounts;
- (3) encouraging the Federal Government to abolish or at least reduce the high volume of betting and sports betting advertisements that saturate our televisions, media and social media outlets, noting that there are limits and/or bans on the advertising of the selling of alcohol and cigarettes, yet despite the significant harm of excessive gambling, there are few constraints to gambling advertising; and
- (4) introducing a Magistrates' Court gambling intervention program (GIP), similar to that which operates in South Australia, where a therapeutic approach is applied for offenders who have committed low level criminal offences, and upholding the same application that occurs in Victoria's Drug Courts for those with drug and/or alcohol dependencies.'

Mr Northe addressed the House — Discussion followed.
