





COVID-19 Response

- Facilitated procedural arrangements to enable both Houses to sit in a COVID-19 environment
- Support provided to 10 parliamentary committees to undertake inquiries in a COVID-19 environment
- Maintained and enhanced remote work capability
- Supported MPs and EOs wellbeing, training and security
- Responded effectively to significant increase in security incidents
- Construction activity continued across key Parliament House projects and at electorate offices (within COVID limitations)



Supporting members to fulfil their roles as elected representatives

- Implemented Remuneration Tribunal's new guidelines (01/2021) effective from 1 May 2021
- Increased training opportunities for electorate officers, including online delivery options
- Supported Members and EOs (EAP)
- Developed new questions database
- Facilitated remote working arrangements for electorate officers
- Electorate office relocations
 - 8 projects fully completed
 - 2 partially completed
 - 14 projects at various stages


Charity Meals Program

- March 2020 June 2021
- Program operated seven days per week, with three different teams to ensure program continuity.
- Charity meals program delivered 1,500,000 meal items through various charities since the program commenced in March 2020.
- 2019-20
 - Expenditure \$1.0m (funded internally by Department of Parliamentary Services)
- 2020-21
 - Budget \$3.78m (2020-21 ERC)
 - Expenditure \$3.64m



Community Engagement

- Special sitting of the Legislative Assembly at the Royal Exhibition building to present the Royal Commission on Mental Health final report, with 200 invited guests
- Regional sitting of the Legislative Council in Bright and associated committee and education activities in the North East region
- Online incursions for schools replacing on-site visits during COVID and now a permanent offering to support regional participation
- Continued support for our twinned parliaments of Fiji, Tuvalu and Nauru
- Women Engaged in Leadership forum (WE Lead) for young women leaders in March
- Piloted a submissions writing workshop for committee stakeholders




- Implemented new electorate office standards and framework

Electorate Office Security Challenges

- Security team attended to 92% increase in incidents at electorate offices due to COVID-19
 - 2019/20 107
 - 2020/21 205
- 13 individuals charged by Police in 2020-21 for making threats against MPs
- 28 EO Security Overlays were completed in 2020-21
