

Transition to 59th Parliament

- Changeover of MPs and staff in response to election outcomes
- Managing the new Parliament's opening

Key achievements: 77 office changeovers, 21 former MP resettlements, 38 new MP commencements, 129 electorate officer attendance at 9 mandatory induction sessions since January 2019





Parliamentary Precinct renewal

- A contemporary working environment for staff and MPs
- Restoration of a major Victorian heritage asset
- Enhanced spaces inside Parliament House for the community and MPs


