Answer

Treatment vehicles were sourced through a direct request for quote to one supplier before going to build, and a quote was provided. In 2017, Dental Health Services Victoria (DHSV) conducted a successful public tender for a mobile clinic with the contract awarded to G.H. Varley Pty Ltd to supply a single mobile dental vehicle. Based on the successful delivery of this previous project, and the tight timeline to ensure readiness for the proof of concept, DHSV engaged G.H. Varley Pty Ltd to supply the first 10 treatment dental vehicles for the 'proof of concept'.

Procurement for the fleet to deliver the full program will go to tender. The examination vehicles are being leased through VicFleet.

7. Can you confirm that the baby bundle is supplied and distributed by a Victorian company?

Answer

The Andrews Labor Government has committed \$213.7 million to provide more help for new Victorian mums and dads through a comprehensive package of supports for parents, including first-time parents, during the transition to parenthood and the first years of their child's life.

The \$21.9 million baby bundle project is one of these supports. The baby bundle will contain practical resources such as picture books, a teething toy, a nappy bag, a safe sleeping bag, a cotton wrap, a grow suit, a first-aid kit, sun hat, baby toothbrush and information on child health, safety and learning.

The baby bundle aims to help first-time parents to support their children's learning and development through regular reading and playtime, and connect parents to available evidence-based support and advice.

Every effort has been made to source and include locally owned products by Victorian companies. Nearly all the products in the baby bundle have been supplied from local, Victorian owned businesses.

All contents of the bundle meet Australian Safety Standards.

Procurement of the baby bundle is being conducted in two stages.

For stage 1, a sole source approach was undertaken to an end to end supplier who has experience in distributing something of this size and scale. The baby bundles are being packed and distributed to all Victorian maternity hospitals by an Australian-owned small business (Baobag Pty Ltd, based in NSW but who also have a Victorian office base).

For Stage 2, Victorian-owned companies are encouraged to respond to the open-market Request for Tender (RFT) which will be made available publicly in mid-July.

Priority will be given to Australian-made/Australian-owned products, with a preference for Victorian-made/Victorian-owned products (Local Jobs First).

Stage 2 of the RFT also includes social and sustainable procurement. Preference will be given to those who deliver social and sustainable outcomes that benefit Victorian communities, particularly those companies purchasing from suppliers that offer employment to Victorians with a disability or that promote women's equality and safety.

8. How does the government's improved investment in palliative care apply to community-based palliative care?

Answer

We are investing \$10.8 of the \$72 million on community palliative care in 2019-20 and \$45.35 million over four years from 2019-20 to 2022-23.

This includes:

- \$7.0 million to support metropolitan community palliative care providers to respond to growing demand
- \$1.0 million to support initiatives that improve access to palliative care for residents in aged care services
- \$2.8 million to support a range of palliative care service innovation and development
 projects. This funding will support community palliative care services across the state to
 work collaboratively with hospitals and other community groups to improve client and carer
 outcomes. It will enable services to develop and test new models of care and system
 enablers aimed at supporting services to explore ways to champion better integration
 between acute, community and primary palliative care providers.
