#### Relevant text:

What are all the documents that you fulfil that requirement of Section 63 of the Transport Integration Act 2010?

## Answer:

Section 63 of the Transport Integration Act 2010 requires the Department of Transport to prepare and periodically revise a transport plan for the Secretary, who must in turn provide it to the Minister. The Minister may then choose to publish a transport plan.

The Department of Transport is continually undertaking and updating its strategic integrated transport planning to meet the requirement of Section 63 of the *Transport Integration Act 2010*. It considers the transport system through ethnographic, geographic, thematic, and network lenses to determine needs, priorities and actions to help address the State's social and economic outcomes.

The work is published externally through a variety of documents that set out the transport strategies and plans across the State.

# These documents include:

- Victorian Infrastructure Plan sets out the Government's response to Infrastructure Victoria's 30-year Infrastructure Strategy and details the transport infrastructure investments in new assets and maintenance
- *Plan Melbourne* transport actions to respond to land use planning for Melbourne and regional Victoria
- Western Rail Plan A plan for how the Western Melbourne growth areas and regional centres of Geelong and Ballarat will be served by rail (including fast rail services to Geelong and Ballarat and the western section of the Suburban Rail Loop and Melbourne Airport Rail)
- *Trains, Trams, Jobs 2015-2025 Victorian Rolling Stock Strategy* committed 10-year pipeline of tram and train assets and associated industry development to meet the future needs of the transport system
- Regional Network Development Plan guides short, medium, and long-term priorities for the regional transport network
- Delivering the Goods Victorian Freight Plan sets out priorities and actions to meet freight challenges to 2050

- **Growing our Rail Network 2018-2025** detailing the integration of the Metro Tunnel with the existing network

In regards to the funds allocated to the St Kilda Road Safe Bike Lanes in 2019/20, what is that actually going to be spent on?

# Answer:

The government is investing \$27 million to make St Kilda Road safer for all users with new cycle lanes that physically separate drivers and cyclists.

The first year of funding for the St Kilda Road Bike Lanes project in the 2019-20 State Budget will be used to develop a full business case.

As part of this process, Major Roads Project Victoria (MRPV) will carry out traffic and parking studies and desktop assessments to develop concept designs. The business case is expected to be finalised by mid-2020.

Once finalised, the business case will outline the upcoming activities and remaining expenditure for the delivery of the project.

#### Relevant text:

Minister, just on bridges, can I just leave a matter with you to probably take on notice. Obviously, Fiona Richardson was a very dear friend of mine, as she was of yours and others in the Parliament. She was passionate about having the Chandler Highway bridge effectively replaced, and I would have thought that it was quite fitting to have that bridge renamed as the Richardson Bridge. So, can I just allow you to take it on notice and come back to us with what needs to happen for that to potentially occur?

# Answer:

Fiona Richardson was a friend and colleague and a person who achieved much for her community and the State, particularly in relation to combating family violence.

There are four processes outlined in the Naming Rules for Places in Victoria for the naming of a feature by a Government department or authority. The naming authority should work with Geographic Names Victoria to determine which process is most appropriate to the situation.

# The possible processes are:

- VicRoads can work with Geographic Names Victoria to make an in-house determination on an appropriate name. The name could then be endorsed by the relevant Minister or a Geographic Place Names Advisory Committee and be ratified by the Registrar of Geographic Names.
- VicRoads can develop a public consultation process and work with Geographic Names
   Victoria to determine a final naming proposal. A Geographic Place Names Advisory
   Committee or the relevant Minister can make a final decision.
- VicRoads can develop a name proposal through a public naming competition. Geographic Names Victoria should be contacted regarding appropriate formats for the competition forum.
- 4. The Minister for Roads can seek a Ministerial direction by writing to the Minister for Planning to request powers under S11(5) of the *Geographic Place Names Act 1998* be used, and the Registrar of Geographic Names be directed to enter the name in VicNames.
