 BP3, p. 50 – there does not appear to be a line item related to programs funded under Stage 1 of the Ice Action Plan, including Community Ice Action Grants. Why have you axed funding for these community led programs that have helped footy clubs, schools and community groups take proactive action to help manage and avoid the devastating impact of Ice in their communities?

#### Answer

The Victorian Government is committed to reducing the harm caused by alcohol and other drugs. In 2019-20, the Victorian Government is investing a record \$273.1 million in alcohol and other drug services, representing an increase in investment of 65 per cent through the last five State Budgets.

As part of this commitment, the government has extended current funding arrangements for a range of initiatives for 2019-20 including \$1.6 million for activities under the Ice Action Plan.

Funding for Stage 1 of the Ice Action Plan has been continued for many services, including for the Needle and Syringe Program, family drug support services, ice education for families and mental health and alcohol and other dug support practice leaders ice training.

3. Minister, in March 2018 you made a commitment to provide 100 additional Alcohol and Other Drugs (AOD) rehab [rehabilitation] beds. How many extra public rehab [rehabilitation] beds were provided from the date you made that commitment to the election?

#### Answer

Since 2014-15, the Andrews Labor Government will have more than doubled the number of alcohol and other drug residential rehabilitation beds in Victoria, from 208 in 2014-15 to 492 once all facilities are fully operational.

This includes funding through the Ice Action Plan and the Drug Rehabilitation Plan and means that Victorians across the state with complex care needs can access quality treatment, faster for their alcohol and drug issues.

In October 2017, the Government announced that it would establish 100 extra residential rehabilitation beds by March 2018 as part of the Drug Rehabilitation Plan. An additional 100 public residential rehabilitation beds were established prior to the recent election.

Between October 2018 and February 2019, a further 20 adult residential rehabilitation beds opened at the new Grampians residential rehabilitation facility.

The 2019-20 State Budget announced \$10.2 million to operationalise 30 beds at the Hope Restart Centre in Gippsland. This is in addition to funding from the 2018-19 State Budget to construct purpose-built alcohol and other drug residential rehabilitation facilities in the Barwon, Hume and Gippsland regions. This includes 30 bed adult residential rehabilitation facilities in Corio and Wangaratta, as well as a new 20 bed youth-specific residential rehabilitation service in Traralgon – meaning that, once fully operational, hundreds more people in regional Victoria will access treatment, closer to home and family.

  - a. If so, was there was a significant premium attached to leasing these private rehab beds. What was that premium or cost per bed?
  - b. What was the total funding required to fulfil the commitment of 100 additional rehab [rehabilitation] beds?

#### Answer

In October 2017, the Andrews Labor Government made a commitment to establish 100 additional residential rehabilitation beds in Victoria. One hundred additional beds were available by March 2018 to meet urgent demand for services and improve access to treatment for people who were struggling.

The Drug Rehabilitation plan provided \$53 million over four years to establish 100 additional residential rehabilitation beds at both new and existing public facilities across the state.

It was vital that services were up and running as soon as possible – that is why the government worked with a range of partners in the public and private sector. While some of the public facilities were being established, beds were contracted from private providers. No additional funding was required.

Since 2014-15, the government will have more than doubled the number of alcohol and other drug residential rehabilitation beds in Victoria, from 208 in 2014-15 to 492 once all facilities are fully operational.

This government's investment in residential rehabilitation beds in Victoria will provide around 900 more Victorians with access to residential rehabilitation services every year – more than half of these will be based in regional Victoria.

5. I refer to BP3, p. 57 regarding the Injecting Room. Minister, in your data provided regarding the Richmond Injecting Room you refer to the number of 'saved lives' or people who have had medical assistance following drug use. Minister, how many unique individuals does this include?

## Answer

The transitional medically supervised injecting room is saving lives and reducing drugrelated harm. Since the medically supervised injecting room opened on 30 June 2018, trained staff have safely managed over 1,130 overdoses that may otherwise have been fatal had there been no one to resuscitate them.

North Richmond Community Health has advised that these overdoses include a proportion of clients who have had overdoses safely managed more than once.

## **Relevant text**

7. Regarding the critical mental health service demand initiative, what will be the average, and maximum, number of treatment hours per annum, per client as a result of this funding?

#### Answer

The Andrews Labor Government has committed \$28.7 million over two years to give more than 7,000 people access to earlier care and support through additional clinical mental health services in the community. This will give more Victorians experiencing mental illness better treatment and care, closer to home.

The Department of Health and Human Services Annual Report 2017-18 provides information regarding total community service hours delivered by mental health services and total registered community clients (p. 86). These figures could be used to derive an estimate of the average number of community service hours per client; however, an average calculated in this way does not necessarily give an accurate view of the support available to a client.

The Department of Health and Human Services (the department) does not stipulate a maximum number of community service hours per client. The department sets targets for the number of service hours delivered by each health service. However, the number of treatment hours for a client is determined by their treating team based on clinical need.
