



COVID-19 Response

- Facilitated procedural arrangements to enable both Houses to sit in a COVID-19 environment
- Support provided to parliamentary committees to undertake inquiries in a COVID-19 environment
- Maintained remote work capability
- Supported MPs and EOs wellbeing, training and security
- Responded effectively to significant increase in security incidents
- Construction activity continued across key Parliament House projects and at electorate offices (within COVID limitations)
- Mandatory vaccination for members and staff

- Supported Members and electorate officers (Employee Assistance Program)
- Developed new questions database
- Facilitated remote working arrangements for electorate officers
- Electorate office relocations in 2021-22 (as at 30 April 2022)
 - 8 projects fully completed
 - 4 projects at various stages

Upgrading the people's house for future generations

- Contemporary work spaces that are OH&S and DDA compliant for MPs and staff
- Stage 12 of Stone Façade Restoration project completed in November 2021 with Stage 13 (final stage) underway
- Stage 3 (final stage) of East Wing project underway






Electorate Office Security Challenges

- Security team attended to a substantial increase in security incidents at electorate offices due to COVID-19 restrictions and pandemic legislation
 - 2019/20: 107
 - 2020/21: 205
 - 2021/22: 263
- The four most significant incident types at EO's
 - Threats & Intimidation
 - Vandalism & Graffiti
 - Observation of Concern
 - Demonstration



New electorate office security interface




Number of Monthly Security Incidents @ Electorate Offices 21/22


