Budget boost for at-risk children, families and carers – Children and Families

The 2022-23 budget invests \$271.6 million across child protection and family services, building on last year's \$1.2 billion boost for at-risk children, their families and carers.

This represents a total new investment in Children and Families to almost \$2.9 billion over the four years from 2019-20 to 2022-23:

- Total annual investment has increased by
 over 35 per cent since the 2018-19 Budget
- Total annual investment has increased by
 over 84 per cent since the 2015-16 Budget

Investment highlights – meeting growing demand

\$84.6 million over 2 years for Improving the Capacity and Mix of Care Services

\$57.6 million over 3 years for Responding to Demand for Child Protection and Family Services to meet increasing demand for targeted and specialised family services, incl:

Family services support to up to 1,000 additional vulnerable

families

\$7.2 million over 2 years for Advancing AboriginalSelf Determination and Closing the Gap



Investment highlights – safety of children and young people

Investment continued...

- > \$9.1 million over two years to Improve the safety of children and young people in out of home care to deliver quality and enabling infrastructure
- \$9.8 million across two years for Funding for Statutory Bodies and Reforms

For implementation of the *Child Wellbeing and Safety* (Child Safe Standards Compliance and Enforcement) Amendment Act 2021



Investment highlights – responsiveness and sustainability

Investment continued...

> \$63.7 million over 4 years to support community sector jobs

> \$25.3 million for 2022-23 for Civil Claims Costs for Historical Institutional Child Abuse

For settlement of civil claims for historical institutional child abuse suffered by former wards of the State while in the State's care



Investment highlights – providing better support

Investment continued...

> \$2.0 million over 4 years for justice system costs associated with additional judicial resources and the extension of court programs

\$1.8 million allocated in 2021-22 to fund a short extension of the 'Coronavirus Emergency Response for Children and Young People'

\$10.4 million over three years to strengthen the community services workforce

To undertake an attraction and recruitment campaign that raises the profile of the community services workforce
