


Strengthening inclusion and safeguards for Victorians with disability

- > **\$12.4 million** continuing the work of statutory bodies
- > \$8.3 million supporting the State Disability Plan
- > \$7 million improving forensic disability services through early intervention programs, an Aboriginal selfdetermination strategy, and data analytics for better service integration
- Victoria continues to contribute approximately
 \$2.9 billion annually to the National Disability Insurance Scheme (NDIS).



Advancing disability inclusion through vital facilities, services and education



Invested \$13.21 million in Changing
Places facilities since 2015. This
funding has contributed to 34 of the
114 changing places currently
operational. The investment also
funds a further 36 places that are
currently in design or construction.

- Third wave of the "Change your reactions" campaign launching soon.
- Over 450 Specialist Disability
 Accommodation homes upgraded across Victoria.

Continuing critical supports for older Victorians, carers and aged care

- \$42.2 million to support better aged care services including
 \$30.5 million to maintain Victoria's nurse to resident ratios and support for residents with complex needs and
 \$11.7 million to uplift Residential in Reach capacity
- \$38 million invested in the Additional Support for Carers program, which supplements the recurrently funded Victorian Support for Carers Program
- > **\$3.5 million** for the Seniors Rights Victoria support service
- > \$2.5 million towards elder abuse prevention networks for communities across Victoria.



Supporting older Victorians, carers and communities

We are celebrating and supporting Victorians to participate and engage in their local communities.

- The Seniors Card, Carer Card and Companion card make it more affordable for more than 1.3 million Victorians to get out and about.
- > The annual Seniors Festival engages Victorian seniors online and across the state with almost 2,000 events.
- The Victorian Support for Carers and Additional Respite for Carers programs jointly support 13,000 carers and provide 260,000 hours of respite.
- > 400 neighbourhood houses combat social isolation and loneliness and help Victorians access the Victorian Sick Pay Guarantee and \$250 Power Saving Bonus.
- Helped revitalise volunteering through the \$1 million Emerging Stronger grant program.

Reforming policy and legislation

- > The Disability and Social Services Regulation Amendment Act 2023 passed in May 2023.
- Inclusive Victoria: State Disability Plan 2022–2026 is being implemented and work is underway to refresh the Victorian Autism Plan.
- Victoria continues engagement with the Royal Commission into Violence, Abuse, Neglect and Exploitation of People with Disability and the Independent Review of the NDIS.
- The new Social Services Regulator is being established to help keep Victorian social service users safe.
