



Established under the Court Services Victoria Act 2014




Independent statutory body providing the administrative services and facilities necessary for the Victorian courts and VCAT to operate independently from the executive branch of government

## **New Courts focussed on supporting court users**

#### **Bendigo Law Courts – opened February 2023**

A modern, fit for purpose court that puts people and community first

- Specialist Family Violence Court February 2023
- Magistrates' Koori Court April 2023
- County Koori Court July 2023
- Assessment and Referral Court July 2023
- 11 courtrooms, 2 hearing rooms, 2 mediation suites, remote witness facilities, secure entrances, safe waiting areas, dedicated jury areas, 16 holding cells - for use by all Victorian courts, VCAT, Federal Circuit, Family Court of Australia and justice partners

### Wyndham Law Courts – opening in early 2025

- Integrated, user-centred justice services to the local Wyndham community in Melbourne's west
- 13 courtrooms, 4 hearing rooms, 3 meditation suites and 26 day holding cells
- Will service the Magistrates' and Children's Courts, VCAT and justice partners



# Courts developments focussed on supporting court users

# Dandenong Children's Court – opened June 2023

- Improved access to justice and outcomes for vulnerable children, young people, and families in Melbourne's southeast
- Features 3 courtrooms specifically designed for Children's Court cases, a Children's Koori Court, and critical safety features for vulnerable court users

# Sunshine Law Courts development – completed August 2023

- Addressing significant demand pressures in Melbourne's rapidly growing western corridor
- Features 2 new courtrooms, conversion of two courtrooms to custody courtrooms, upgraded facilities and improved safety



### **Towards Self-determination**

CSV Self-determination Plan – improving access to, participation in and effectiveness of court programs and services for Koori people

#### **Koori Engagement and Consultation Framework – October 2022**


- Business processes guided by principles of self-determination and inclusion
- Seven steps to guide engagement or consultation with Koori stakeholders and community

#### **Koori Employment Plan**

- Improving and providing pathways for the attraction, recruitment and retention of Koori staff
- 79 staff identified as Aboriginal and/or Torres Strait Islander, representing a 2.7% Koori employment rate
- Committed to achieving a minimum 3% Koori employment rate by 2025

#### **Cultural Immersion Program**

- 145 staff across the Courts Group have completed cultural awareness training
- 76 participants have attended 'On Country' immersions



## Reducing pending caseload and increasing access to justice for Victorians

Overall pending caseload reduced by 22% over 2 years to June 23

Pending County Court criminal trials reduced 23% (Jan-22 to Jun-23)

Supreme Court clearance rate for trials and pleas of 146% in 2022-23

vCAT case clearance rate of 98% in 2022-23 incl 45,000+ Residential Tenancies cases (a 34% increase on 2021-22)

206,531 public enquiries,
enabling Registrars to
provide in-person support

**169,905** Family Violence Contact Centre enquiries in 2022-23

## Innovative and therapeutic justice programs making a difference

#### Drug Courts – intensive supervision/treatment to those with entrenched drug and alcohol dependency

- MCV Drug Courts launched in Shepparton and Ballarat in early 2022
- Preliminary evaluations indicate success and cost savings across the justice system

#### Court Integrated Services Program (CISP) in Indictable Crime Stream – CCV and MCV

Evaluation found \$14.4 million justice system savings over three years and benefit-cost ratio of 2.44

#### **Active Case Management**

- Improved pre-trial active case management has increased efficiencies and assisted Supreme and County Court judges to conduct hearings and trials
- Preliminary evaluation indicates improved access to justice with a positive benefit-cost ratio outcome

#### Assessment and Referral Court – supporting complex mental illness or cognitive impairment needs

• At seven locations across the state and expanding to eight more locations as recommended by the *Royal Commission into Victoria's Mental Health System* 

## Workplace safety and culture

#### **Gender Equality Action Plan**

- Inaugural Gender Equality Action Plan launched in August 2022 including 6 key strategies to support a psychologically safe workplace culture
- 13 of 34 deliverables completed in 2022-23

#### Response to Review of Sexual Harassment in Victorian Courts

- 14 of 16 recommendations implemented
- Your Safe Space has delivered training sessions on eliminating inappropriate behaviours in the workplace
- Robust complaints and resolution process provides multiple avenues for support and reporting

#### **Strengthening Workplace Safety**

- Cross jurisdictional engagement in identifying and addressing risk
- New systems in place to help identify issues of workload and vicarious trauma
- New Peer Support Program, Mental Health First Aid Training, and clinical wellbeing services
