

COVID-19 NATIONAL PRINCIPLES FOR SCHOOL EDUCATION

Summary of seven principles

- Education is best delivered by teachers to students in the classroom.
- 2 During the COVID-19 crisis alternative flexible, remote delivery of education services may be needed.
- Schools must be healthy and safe environments for students, teachers and other staff.
- State and Territory Governments and nongovernment sector authorities are responsible for managing their school systems.

- 5 Decisions regarding the response to COVID-19 in the schooling sector must be informed by expert, official, national and state-based public health and education advice.
- All students must continue to be supported to ensure participation in quality education during the COVID-19 crisis.
- The health advice consistently provided by the AHPPC is that attendance at a school campus for education represents a very low health risk to students.

P-2 and Senior Secondary students return to on-site schooling 26 May – 5 June

Prep – 2, years 11 and 12, and specialist school students

Students in Prep to Grade 2 and students in Year 11 and 12, and all students at specialist schools will return to on-site schooling first.

Grade 3 – Year 10 students

Students in Grade 3 to Year 10 who can learn from home must continue to learn from home.






Percentage of students on-site



EARLY CHILDHOOD

Supporting Early Childhood Education and Care Services



- Additional **\$498** for each fee-paying enrolment for eligible services for Term 2
- Based on fee subsidy (KFS) + the KFS Ratio Kindergarten Supplement, pro rata for Term 2
- Funded Three-Year-Old Kindergarten in the 2020 rollout areas also eligible
- Funding also available for unfunded sessional programs for three-year-olds in Term 2.





EARLY CHILDHOOD

Learning from home

Some families are keeping their children at home. For most services, attendance is:

- Sessional kindergarten: 30-50 per cent
- Long day care: 40-70 per cent*

*data provided by peak bodies



School Readiness Funding

- Flexibility for services receiving SRF to pay for additional resources and staff time to support learning from home
- An additional **\$900,000** for services not yet getting SRF to do the same.

The Department has also provided:

- professional learning webinars for early childhood staff
- a repository of high-quality play-based learning activities
- additional advice and resources on a new learning from home website.


