## PAEC INQUIRY INTO THE PARLIAMENTARY BUDGET OFFICER – RESPONSE TO QUESTIONS ON NOTICE

Thank you again for the opportunity to appear before this important inquiry into the Parliamentary Budget Officer (PBO). I am pleased to provide further information regarding the two questions on notice relating to my evidence.

The first question sought, for each department, the number of information requests from the PBO and the number of responses received.

As my Department does not hold such information, this information was requested from other Departments and collated by my Department. This information is outlined in Attachment A. My Department has not reviewed or independently verified the data.

I note that the PBO would also be able to provide or verify this information if required by the Committee.

The second question related to whether the PBO has requested, and whether my Department has provided, any escalation rates or unit costings in relation to capital projects.

In each information request that the PBO has made to my Department, the PBO expressly notes that the information requests are confidential and must not be disclosed unless disclosure is required to respond to the information request. Noting this, I consider I am not in a position to disclose information relating to PBO requests.

Should the Committee require it, I note that the PBO may be able to provide this information.
