Have your say

The Electoral Matters Committee wants to hear about your experiences at the 2022 Victorian state election and your views on how the election was conducted. The Committee would also like to know about any changes that you believe would improve future elections.

You can send a written submission to the Committee discussing any matter related to the 2022 Victorian election, including:

- voters' experience enrolling and casting their votes
- the behaviour of parties, candidates and campaigners during the election period
- the way the Victorian Electoral Commission managed the election
- candidates' and parties' experience standing for election
- possible improvements to Victoria's electoral system, including changes to the Upper House voting system
- any other matters related to the conduct of the election.

The inquiry will consider the 2022 Victorian State election and the 2023 Narracan District supplementary election.

Any person or organisation can make a submission to the Committee.

Making a submission

Submissions add to the Committee's knowledge and understanding of the issues and may influence the Committee's recommendations. By making a submission you are providing important input into the work of the Parliament of Victoria.

Your submission might include relevant experiences, facts or suggested solutions to the issues the Committee is considering. Submissions can be made by email, post or through our online e-submission form.

Submissions are public documents unless you request confidentiality. Requests for confidentiality will be considered but cannot be determined in advance.

Closing date

Our closing date for submissions is 19 June 2023. This date may be subject to change, so please check our website to confirm.

Public hearings

Some individuals and groups will be invited to talk with us at public hearings later this year. Anybody is welcome to be in the audience at a public hearing.

Dates and times will be published on our website as they become available.

Report

The Committee will table a report in Parliament at the end of the inquiry. **The report is due by 1 May 2024**.
