If Councils are to reduce the existing infrastructure gap, external funding is absolutely essential. The additional Roads to Recovery funding provided in 2015-16 and 2016-17 has been exceptional, as has the introduction of the Bridges Renewal Program. The relaxing of the criteria for the Federal Black Spot program has also be most beneficial. The State Government funded Regional Growth Fund of 2012-13 and 2013-14 was an excellent program, which allowed municipalities to deliver valuable projects that would otherwise have taken a number of years. It was disappointing when this program was not continued.
