




#### Vaping by age group 2018 - 2023

#### Strengthening federal laws & closing loopholes

On 21 March 2024, legislation was introduced to Federal Parliament which, if passed, will:

- End the importation, domestic manufacture, supply, commercial possession and advertising of all non-therapeutic and disposable vapes for retailers under a single national framework.
- Introduce new offences and civil penalty provisions for retailers of non-therapeutic and disposable vapes.
- **Ensure patient access** to legitimate therapeutic vapes is through pharmacy settings and under appropriate health practitioner supervision.

Builds on reforms passed by Federal Parliament last year stopping the import of vapes.


