

Select Committee on the 2026 Commonwealth Games Bid

DEPARTMENT / AGENCY QUESTIONNAIRE, SEPTEMBER 2023

The Inquiry

On 2 August 2023, the Legislative Council resolved to establish a select committee to investigate and report on the 2026 Commonwealth Games and the progress of the regional infrastructure build. An interim report is due by April 2024 and a final report is due by April 2025.

Terms of Reference

A Select Committee of nine members be appointed to inquire into, consider and report on the 2026 Commonwealth Games and the progress of the regional infrastructure build, including but not limited to -

- (a) the potential failures in governance, probity and procurement processes in the Victorian Government's bid, contract, and termination of the 2026 Commonwealth Games;
- (b) the impacts of the contract termination of the Commonwealth Games on Victoria's reputation, business community, tourism, and major events;
- (c) the Victorian Government advice received from government departments, councils, agencies, consultants, and contractors;
- (d) the potential of undue influence by the executive on the independence of the public service;
- (e) the timeline, progress and budget of the Victorian Government's regional infrastructure and housing build;
- (f) the impact on community, social, amateur, and professional sport in Victoria;
- (g) any other relevant matter.

Questionnaire to relevant departments and agencies

2022-23: \$0.544 million

The Output for which DPC received Treasurer's Advance (TA) funding is "Economic policy advice and land coordination" (Output Costs Summary, Page 294 of 2023-24 Budget Paper 3 Service Delivery).

DPC received \$0.544 million for 1 x VPS4, 1 X VPS6 FTE, funding support for 0.5 FTE SES-1, and centralised accommodation management costs (including once off fit out cost for the 2 x VPS employees) for one year.

Why additional funding was required

The reason why additional funding was required has been provided as part of response to Question 2.

Additional funding was required for sufficient resourcing to work on 2026 Commonwealth Games and associated Cabinet, governance, delivery planning and cost control processes. This included new engagement and policy coordination with the Office of Commonwealth Games and Organising Committee, supporting the new Commonwealth Games Committee of Cabinet, and budget and delivery oversight.

DPC did not receive any previous funding for the 2026 Commonwealth Games prior to 2022-23.

DPC notes that consultation on the 2026 Commonwealth Games was primarily led by the Organising Committee and the Office of the Commonwealth Games in DJSIR.

DPC engagement was generally limited for community and stakeholder consultation with the exception of the below:

DPC First Peoples – State Relations Group

 DPC First Peoples – State Relations, Heritage Services met with Traditional Owners regarding the preparation of cultural heritage management plans being prepared in areas appointed by Registered Aboriginal Parties. This involved conversations with Wadawurrung Traditional Owners Aboriginal Corporation and Gunaikurnai Land and Waters Aboriginal Corporation to seek to understand how government could better support them to participate in cultural heritage assessments for the preparation of those plans. • Registered Aboriginal Parties are corporations with statutory decision making responsibilities sperate from government. As such, most government engagement was directly between relevant agencies for progressing the Commonwealth Games and the relevant Traditional Owners. As such, FPSR's involvement was limited to advisory and more general support.
