Travel Report – World Hellenic Inter-Parliamentary Association (WHIA) 11 March – 18 March 2022 Kat Theophanous MP

Summary

Highlights

Melbourne-Thessaloniki Sister Cities

On 14 March Ms Theophanous had the opportunity to meet and speak with the Mayor of Thessaloniki Mr. Konstantinos Zervas. They spoke about the longstanding sister-city relationship between Melbourne and Thessaloniki, which has seen the establishment of 'Melbourne Square' within Thessaloniki.



Joint Meeting of the Hellenic Parliament Special Standing Committee on Hellenism of the Diaspora

On 15 March the delegation attended a joint meeting of the Hellenic Parliament Special Standing Committee on Hellenism of the Diaspora to speak about "One Hundred Years Since the Asia Minor Catastrophe".

Ms Theophanous had the opportunity to address the delegation and spoke about the progress being made in Australia towards recognition of the Armenian, Assyrian and Greek genocides –



including through a recent motion of the Australian Parliament. She also highlighted the impact these events

have had on many migrant families in her own community back in Australia, parallels to the Turkish invasion of Cyprus and the need to assist Ukraine as they now suffer the impact of an unjust war.

Building connections with the Greek University Sector

The delegation had the opportunity to meet and speak with a number of major universities based in Thessaloniki, including the University of Macedonia, the American Farm School, Anatolia College and the Aristotle University



of Thessaloniki.

This was a fantastic opportunity to investigate opportunities for cross-promotion in the university sector, particularly for the Greek speaking community of Melbourne who would benefit greatly from the chance to study abroad and gain a deeper connection with their language and culture.

It was insightful to hear about the diverse study offerings of these universities, including some available entirely in English. Ms Theophanous promoted Victoria's strong university sector and opportunities for Greek international students.

She also spoke about her work to retain tertiary Greek language studies at La Trobe University and explored how collaboration with Greek universities might occur to bolster this program long term.

Meeting with the National Archaeological Museum

A significant highlight of the trip was the opportunity to meet with the National Archaeological Museum of Athens (NAM) regarding the upcoming Open Horizons Hellenic exhibition at the Melbourne Museum.

Open Horizons is a partnership with NAM and the Victorian Government, which will see 44 ancient artefacts dating from the Early Bronze Age to the Roman period come to Melbourne and be displayed in an exclusive exhibition at Melbourne Museum.

Funded by the Victorian Government, the exhibition will take visitors on a journey through Ancient Greece exploring how the trade of ideas and goods influenced Greek culture and how they in turn influenced the ancient world.

Ms Theophanous has been working on this exhibition as part of the Open Horizons Advisory Group, and it was wonderful to be able to meet with some of the collaborators at NAM who will soon



be arriving in Melbourne, and speak about the details as we move into the final stage of preparations for the April exhibition launch.
